  - a. billings, repairs, and maintenance;

  - c. North Fort Bend Water Authority matters, including Water Provider Conservation Program updates;
  - d. amend Rate Order; and
  - e. approve Amendment to Service Agreement with Municipal District Services, LLC.
11. Review Maintenance and Capital Improvement Plan.
12. Engineering matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, including:
  - a. Wastewater Treatment Plant;
  - b. Water Plant Expansion; and
  - c. Lakemont Stormwater Reuse Pump Station Rehabilitation.
13. Authorize acceptance and conveyance of easements/deeds/utility deeds, approval of abandonment of easement or facilities, and review of plans.
14. Park project and recreational facility matters, including preparation of plans and specifications, approval of plans and specifications, advertisement for bids, bid review, contract award, Pay Estimates and Change Orders, and acceptance of projects, if appropriate, including:

- a. Creekside Park at Lakemont.
15. TCEQ Phase II Small MS4 General Permit and Storm Water Management Plan, including status of compliance, necessary training, and public comment.
16. Security matters.
17. Review consultant contracts.
